Scholarships

There are four (4) awards of \$ 500 each.

Eligibility

To be considered for a scholarship, the application form must be completed and submitted, along with the Employer Recommendation form.

Applicants for a Scholarship must:

- Be employed by a member company of the Grande Prairie Construction Association
- Be an Alberta resident
- Be registered as an Alberta Apprentice in a trade
- Have passed their first or subsequent period apprenticeship and industry training exam
- Have returned to work for the sponsoring Grande Prairie Construction Association employer
- **Attach a copy of your marks from your training institute**

Applicants must also include two or three paragraphs describing themselves, including what they enjoy about their trade, why they chose a career in the trades, and how this scholarship will benefit them.

Selection

Selection of scholarship recipients is made by a committee established by the GPCA Board of Directors

Recipients will be selected on the basis of their marks, employer recommendation and short description about themselves. Financial need may also be considered in selecting recipients for Scholarship.

Acceptance of Awards

Recipients of this award must have taken their training in the year that the award is to be handed out. Awards will be presented during the month of December. Awards must be claimed within the same fiscal year (by December 31).

Awards are taxable income. This page does not need to be attached when submitting application.
